MINUTE ANNOUNCEMENTS

The presbytery reconvened on Saturday, October 11, 2014 at 8:30 a.m. in Heritage Hall and heard a Theological Discussion on "The Land in God's Covenant with Israel" led by Teaching Elder Ruskin Falls.

COMMITTEE ON MINISTRY

TE Frank LeBlanc, Moderator of the Committee on Ministry presented their report.

The presbytery voted on the following motions:

- 1. That the process of the Korean group moving toward being a Fellowship be withdrawn, and that the Presbytery of Arkansas affirm the "at large" status of TE Young Doo Kim. **PASSED**.
- 2. To approve raising the "Minimum Compensation Package" of the Presbytery of Arkansas to \$52,400, which is the minimum total cost to the church. This Minimum Compensation Package will include a six-week paid parental leave, and at the end of five (5) years of a full-time pastor's ministry in a particular congregation, the Session shall work with the pastor and present a plan to the Committee on Ministry for a sabbatical leave for the pastor during the 7th year of the pastor's service. If a pastor's salary is less than for a full-time position then the proportion of the time that they serve must correspond with the salary. If a pastor does not need to participate in the Board of Pensions program, as required by the Board of Pe3nwsions, then the total minimum effective salary (cash salary and housing) for a full-time call would be \$34,000. The same package is true for Certified Christian Educators and Temporary Pastoral Relationships. PASSED.
- 3. To approve the call of TE Georgia Senor as the Designated Associate Pastor of First Presbyterian Church, Bentonville, effective October 1, 2014 and to end on September 16, 2016, unless otherwise terminated on 30 day notice by the DAP, or the congregation and Presbytery. During the second year of the call all parties will be engaged in a discernment process (see full wording of the covenant) to consider one of three options. The call is for an average, or at least, 40 hours per week, with a compensation package to include:
